- 1. Visit the TDI website to access a Texas Standardized Credentialing Application.
- 2. After completing the application, please gather the following **required** supporting documents:
  - a. State medical license(s)
  - b. Drug Enforcement Administration (DEA) Certificate
  - c. Malpractice insurance face sheet
  - d. Summary of any pending or settled malpractice case(s) *if within 10 or less years old*
  - e. Curriculum Vitae
  - f. Signed Attestation (page 18 of online application print and sign)
  - g. Written Protocol (Nurse Practitioners only)
- 3. Forward completed credentialing application packet to BCBSTX:

## Create and/or update CAQH ProView Profile

Physicians and other professional providers must have a CAQH Provider ID to register and begin the credentialing process.

First Time Users (If you are not registered with CAQH) Registration and completion of the online application is free.

- 1. Get started by going to CAQH ProView to create your profile
- 2. Once you obtain a BCBSTX Provider Record ID and submit a current signed BCBSTX contract/agreement to BCBSTX, BCBSTX will add your name to its roster with CAQH.
- 3. Physicians and other professional providers who do not have internet access may submit their application via fax to CAQH by first contacting the CAQH Help Desk at 888-599-1771.

#### **Existing Users**

1. **If you have already registered your CAQH Provider ID** then complete or update the online credentialing application.

## **Completing the Application Process**

The CAQH ProView standardized application is a single, standard online form that meets the needs of all participating health care organizations. When completing the application, you will need to indicate which participating health plans and health care organizations you authorize to access your application data. All provider data you submit through the ProView service is maintained by CAQH in a secure, state-of-the-art data center.

#### Reference Materials for Completing the UPD Online Application

- Previously completed credentialing application
- List of previous and current practice locations
- Various identification numbers (UPIN, NPI, Medicare, Medicaid, etc)
- State medical license(s)
- Drug Enforcement Administration (DEA) Certificate
- IRS Form W-9(s)
- Malpractice insurance face sheet
- Summary of any pending or settled malpractice cases *if within 10 or less years old*
- Curriculum Vitae

Note: When you are ready to begin entering your data, log into the CAQH ProView database.

#### After completing the online credentialing application, you will also be asked to:

- Authorize access to your information Check the box beside BCBSTX, or you may select "global authorization."
- Verify your data entry/Attest Review the summary of your data for accuracy and completeness, and make any necessary changes.
- Submit supporting documents Fax the applicable documents required to complete your application to CAQH at 866-293-0414.
  - State medical license(s)
  - o Drug Enforcement Administration (DEA) Certificate
  - o Malpractice insurance face sheet
  - Summary of any pending or settled malpractice case(s) (if within 10 or less years old)
  - o Curriculum Vitae
  - Signed Attestation (page 18 of online application print and sign)
  - Written Protocol (Nurse Practitioners only)

**Note:** BCBSTX may contact you to supplement, clarify or confirm certain responses on your application. Therefore, you may be required to submit additional documentation in some situations, in addition to the information you submit through the CAQH ProView database.
