Medical Virtual Visits

You and your covered family members* can get convenient, quality health care from the comfort of home, on your lunch break, or while traveling without having to go to a doctor's office. Virtual medical visits give you access to licensed board-certified doctors, 24 hours a day, seven days a week.** You can also get prescriptions sent to your pharmacy if needed.

*If the patient is 17 or younger, a parent or guardian must be present during the virtual visit.

***For participants with TRS-ActiveCare HD, medical telehealth visits through RediMD apply to the deductible. Once the deductible is met, the plan pays 70% of the Medical Consult

Mental Health Virtual Visits

Teladoc also offers confidential mental health services from licensed therapists, psychologists, psychiatrists, or certified drug and alcohol abuse counselors for participants 13 and older. Parents don't need to be present during mental health appointments for patients aged 13 to 17.

- personality disorders
