DISCOVER MEMBER REWARDS

Show employees how easy it is to **COMPARE, SCHEDULE, and EARN** with Member Rewards.



COMPARE

Participants can use [Provider Finder®](#) to search for rewards-eligible locations for a service or procedure. They can also connect with a Personal Health Guide (PHG) by calling **1-866-355-5999**, or chatting through the BCBSTX App for help.



SCHEDULE

Participants will ask their PCP for a referral to the location they chose. Once they get the referral, they'll call and schedule the procedure or service. A PHG can also schedule the appointment.



EARN

The reward will be deposited into a Health Care Account (HCA) once participants have completed their treatment, their claim is paid, and the location is verified.**

Here are some features of the Member Rewards program:

- Rewards may apply toward the costs of future medical or pharmacy expenses by reducing copays or coinsurance.
- The maximum reward amount per participant, per plan year is \$599.
- Unused rewards roll over to the next plan year, but participants will lose rewards if they cancel their health plan.
