

How Does it Work?

- Ask your Primary Care Provider for a referral, then schedule the procedure or service at the location you chose or have a PHG schedule the appointment for you.
- We'll deposit your reward into a Health Care Account (HCA)* once you've completed your treatment, the claim is paid, and the location is verified as rewards eligible.
