



Universal Health Services, Inc. contract negotiations

As you may know, Blue Cross and Blue Shield of Texas received a termination notice from Universal Health Services, Inc. stating its intent for their behavioral health hospitals to leave all BCBSTX provider networks, including the network for your TRS-ActiveCare health plan, on **Nov. 22, 2023**. We've worked hard to try and reach a resolution. However, we were unable to find common ground.

UHS is now out of network

Effective immediately, UHS behavioral health hospitals no longer participate in BCBSTX or TRS-ActiveCare networks. This means if you get care from UHS behavioral health hospitals for non-emergency care:

- Services may be paid at the out-of-network benefit level, which may increase your out-ofpocket costs.
- Services may not be paid at all if you have the TRS-ActiveCare Primary and TRS-ActiveCare Primary+ plans.
- You may also be billed more than the allowable amount in any TRS-ActiveCare plan.

Finding new providers

Our goal in contract negotiations is always to give you access to quality, cost-effective health care. Our primary focus now is to ensure an easy transition to other behavioral health hospitals for care.
